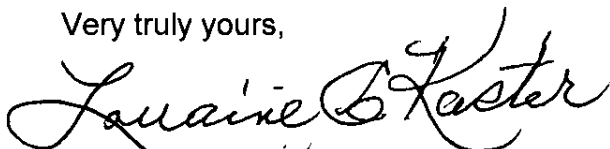

**ARTICLE I - Name**

**EFFECTIVE DATE** 10/19/09

The name of the corporation shall be: **INTERNATIONAL AVIATION RECRUITING & CONSULTING, INC.**

**ARTICLE II - Duration**

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

**ARTICLE III - Purpose**

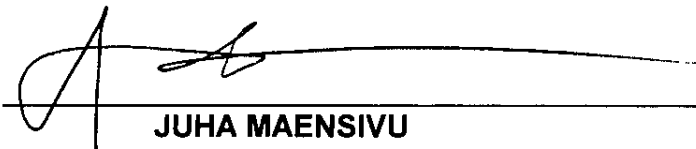
