

ARTICLE I

The name of this corporation is 900 Biscayne Mezzanine I, INC. (the "Corporation").

ARTICLE II

The purpose for which the Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act (the "Act").

ARTICLE III

The address of the principal office and the mailing address of the office of the Corporation is 1000 East Hallandale Beach Blvd, Hallandale Beach, Florida 33009.

ARTICLE IV
