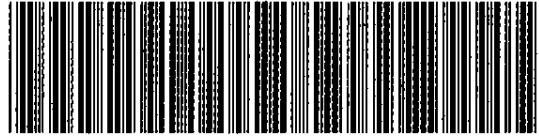

**ARTICLES OF INCORPORATION OF  
SPECIALIZED ACCOUNTING RESOURCE, INC.**

The undersigned hereby adopts the following articles of incorporation for the purpose of forming a corporation under the laws of the State of Florida.

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**
