#### ARTICLES OF AMENDMENT

## TO THE ARTICLES OF INCORPORATION OF FLORIDA INTERNATIONAL BLIND FACTORY DEPOT, INC.

### a Florida corporation

### Document No. P09000089881

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendments to its Articles of Incorporation.

FIRST: The Corporation hereby deletes Article IV of the Articles of Incorporation in its entirety and replaces it with the following Article IV:

### "Article IV - CAPITAL STOCK

The maximum number of shares of stock this Corporation is authorized to have outstanding at any time shall be as follows:

- a. I voting share; and
- b. 999 non-voting shares.

All of said shares shall have equal preferences, limitations and relative rights, including rights to distribution and liquidation proceeds, except that with respect to all matters coming before the shareholders for a vote of the shareholders: (i) a holder of non-voting stock shall not be entitled to vote, individually or as a class, and (b) a holder of voting stock shall be entitled to cast one vote per share."
