ARTICLES OF INCORPORATION

MARCUM BROTHERS UNDERGROUND, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Marcum Brothers Underground, Inc.

ARTICLE II

The existence of the corporation shall begin on November 2, 2009

ARTICLE III

The address of the principal office of the Corporation is 291 Milton Street, Port Charlotte, Florida 33954.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The par value is \$1.00.

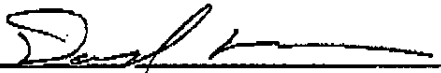
