The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation of such corporation:

ARTICLE I - CORPORATE NAME

The name of the corporation shall be Krave Salon & Boutique, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and the State of Florida, or any other state, country, territory or nation. The purpose of the corporation is to conduct a hair salon and boutique.

ARTICLE IV - AUTHORIZED SHARES

The aggregate number of shares of stock that the corporation is authorized to have outstanding at any time is 100 shares, with a value of \$10 (ten dollars) per share. The shares of the corporation are not to be divided into classes.

This corporation shall have (2) directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.
