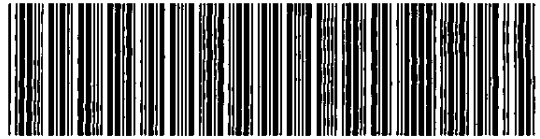



ARTICLE I - NAME

The name of the Corporation shall be TREASURERS FOREVER YOURS, INC.

ARTICLE II - EXISTENCE

The Corporation shall have perpetual existence and shall begin its operations upon the approval of these Articles of Incorporation by the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE




