ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Alpha Media Holdings, Inc. and its principal office is located at 14523 Neptune Road, Seminole, FL 33776 and mailing address is P.O. Box 1047, Indian Rock Beach, FL 33785.

Commencement and Term of Corporate Existence

By-Laws


