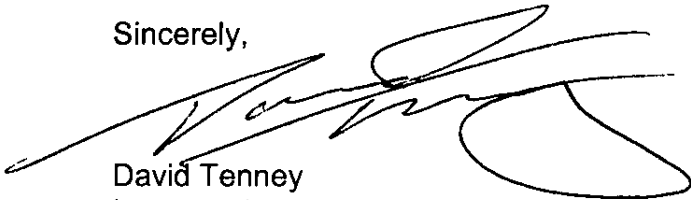

OF

ARTICLE I. NAME

The name of the corporation shall be: **INFLUENCE HOUSING, INC. (the "Corporation")**.

ARTICLE II. PRINCIPAL OFFICE

The street address of the principal office and the mailing address of the corporation is Influence Housing, Inc., 13112 Royal George Avenue, Odessa, FL 33556.

ARTICLE III. SPECIFIC PURPOSE FOR CORPORATION

The specific purpose for which the Corporation is organized is to create and provide affordable, decent, safe, and sanitary quality housing opportunities to meet the needs of economically disadvantaged low-income individuals and their families (eligible families, senior citizens, and disabled persons) who are unable to obtain affordable housing.

ARTICLE IV. SHARES

The aggregate number of shares of capital stock which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.

ARTICLE V. INITIAL OFFICERS AND/OR DIRECTORS

The Corporation's Board of Directors (the "Board") shall consist of not fewer than one (1) nor more than five (5) directors, and shall initially consist of one (3) directors. The number of directors within these limits may be increased or decreased from time to time as provided in the By-Laws of the Corporation.

ARTICLE VI. REGISTERED AGENT

The Florida Street address of the registered office of the Corporation is 13112 Royal George Avenue, Odessa, FL 33556 the name of the Registered Agent of the Corporation at that address is David Tenney.

ARTICLE VII. INCORPORATOR.

The name and address of the incorporator of the Corporation is David Tenney, 13112 Royal George Avenue, Odessa, FL 33556

ARTICLE VIII. LIMITATION ON DIRECTOR LIABILITY

A director shall not be personally liable to the Corporation of the holders of shares of capital stock for monetary damages for breach of fiduciary duty as a director, except (i) for any breach of the duty of loyalty of such director to the Corporation or such holders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 607.0831 of the Florida Business Corporation Act (the "FBCA"), or (iv) for any transaction from which such director derives an improper personal benefit. If the FBCA is hereafter amended to authorize the further or broader elimination or limitation of the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the FBCA, as so amended. No repeal or modification of this Article VII shall adversely affect any right of protection afforded to a director of the Corporation existing immediately prior to such repeal or modification.

ARTICLE IX. INDEMINIFICATION

The Corporation shall indemnify and advance expenses to, and may purchase and maintain insurance on behalf of, its officers and directors to the fullest extent permitted by law as now or hereafter in effect. Without limiting the generality of the foregoing, the By-law may provide for indemnification and advancement of expenses to officers, directors, employees and agents on such terms and conditions as the Board may from time to time deem appropriate or advisable.

ARTICLE X. BY LAWS

The Board shall have the power to adopt, amend or repeal the By-laws of the Corporation or any part hereof.

ARTICLE XI. AMENDMENT

The Articles of Incorporation may be altered, amended or repealed by the shareholders of the Corporation in accordance with the applicable provisions of Florida law.

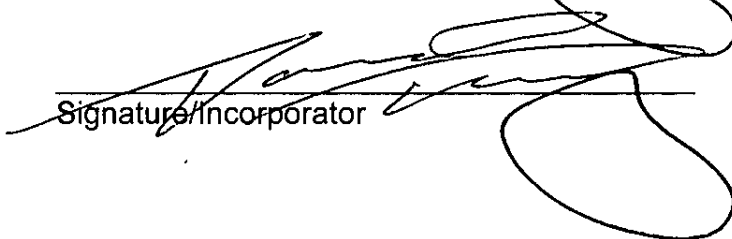
