ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Florida Statutes, Section 607.0101 *et seq.*, hereby adopts the following Articles of Incorporation of Sharing Central Inc ("SCI"):
