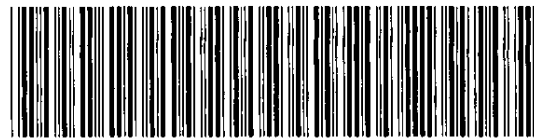


ARTICLE XI AMENDMENT
