

ARTICLES OF INCORPORATION OF ROESSER ENTERPRISES, INC.



ARTICLE I

NAME

The name of the corporation is Roesser Enterprises, Inc. and its mailing address is 133 Country Villas Dr., Safety Harbor, FL 34695.
