## ARTICLES OF INCORPORATION

#### <u>ARTICLE I - NAME</u>

The name of the corporation is Allen Brothers Services, Inc., at 2916 North Shell Road, Deland, FL 32720 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any of all lawful business.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".
