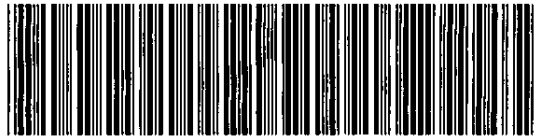

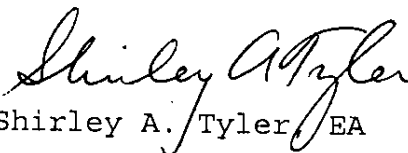

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: AFFORDABLE FLOOR SOLUTIONS, INC. INC. The principal place of business will be 233 N.W. Monroe Circle N, St. Petersburg, FL 33702

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT

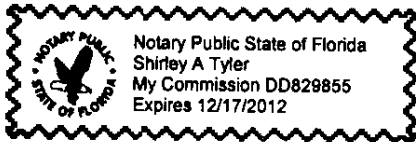
