The undersigned for the purpose of forming a corporation under the Florida Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: YES REALTY 2, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE TERES

The general purposes for which the corporation is organized are:
