In compliance with the requirements of Fla.Stat. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("**Corporation**") is CleanConcierge, Inc.

ARTICLE II

The existence of the corporation shall begin immediately upon the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III

The street address of the principal office of the Corporation is 975 Keller Road, Suite 1500, Altamonte Springs, Florida 32714.

ARTICLE IV

The maximum number of shares the Corporation is authorized to issue is One Thousand (1,000), all of which shall be common shares with a par value of One Dollar (\$1.00). All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one (1) vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 315 E. Robinson Street, Suite 600, Orlando, Florida 32801. The initial registered agent for the Corporation at that address is Anthony M. Nardella Jr., Esq.

ARTICLE VI

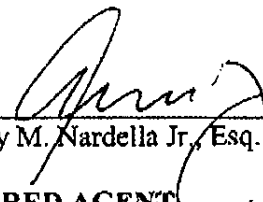
ARTICLE VIII

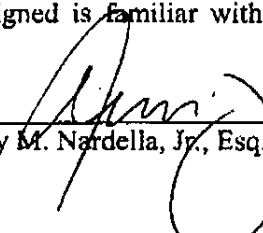
