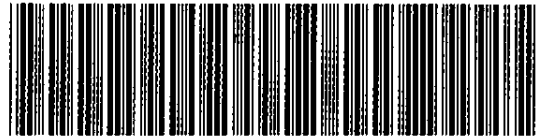

ARTICLE I - Name

The name of the corporation shall be: **NAIL DEPOT SERVICES, INC.**

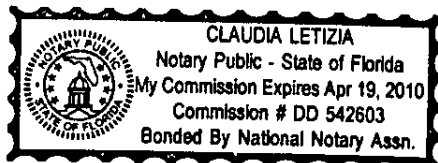

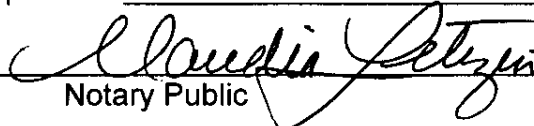

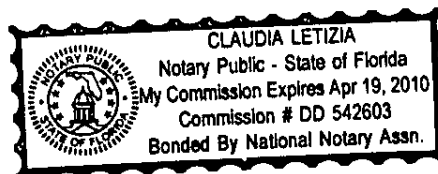
