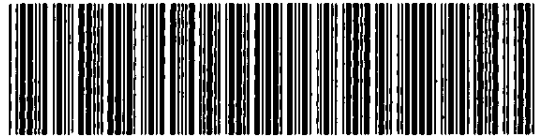

This corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock.

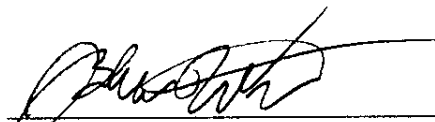

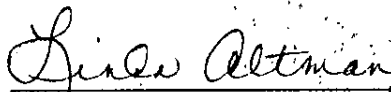
