

#### ARTICLE I Name of Corporation

The name of the corporation shall be TSM & MJM INVESTMENTS, INC.

#### ARTICLE II Principal Office

The address of the principal office of TSM & MJM INVESTMENTS, INC. shall be 2145 Aberdeen Lane No. 203, Naples, Florida 34109.

# ARTICLE III Purposes and Powers

Directors, including, but not limited to, stocks, bonds, secured and unsecured obligations, undivided interests, leases, commercial paper, financial and governmental instruments, savings and other depository accounts, and other securities and properties;

- (d) To give, donate, and contribute to any of the activities TSM & MJM INVESTMENTS, INC. may elect to sponsor, or in furtherance of any of the aforesaid purposes for which TSM & MJM INVESTMENTS, INC. is organized, such money or property, or both, as TSM & MJM INVESTMENTS, INC.'s Board of Directors may from time to time determine;
- (e) To take title to, and hold in its own name, such real or personal property, or both, and such interests in either such type of property as TSM & MJM INVESTMENTS, INC. may acquire, for the purposes herein set out, and to sell, transfer, and dispose of any such property, or reinvest the proceeds thereof as herein permitted;
- (f) To accept gifts, bequests, or devises of property of any kind which any individual, firm, corporation, or other entity may make to TSM & MJM INVESTMENTS, INC., upon the terms, trusts, and conditions set forth in the deed of gift, will, or other instrument of writing, executed by any such donor or testator, but only for the purposes and upon the terms and conditions and with the powers set forth in these Articles of Incorporation;
- (g) To borrow money and give security therefor by pledging, mortgaging, or otherwise hypothecating any property it may own, or any interest it may have in such property;
- (h) To become a member of any other nonstock or nonprofit corporation organized under the laws of any state, or to become affiliated with any other organization of like character existing under the laws of any state; provided, however, that such corporation or organization is an exempt organization under section 501(c)(3) of the Code;
- (i) To the extent permitted by law, to enter into contracts with any corporate trust company for the purpose of delegating to it the power, or employing it, to make investments on behalf of TSM & MJM INVESTMENTS, INC., and to do such other things permitted by these Articles of Incorporation as the parties may agree upon, and without limiting the generality of the foregoing, but in furtherance thereof, to enter into trust agreements, irrevocable or otherwise, with any such corporate trustee, and therein to authorize any such corporate trustee to employ

agents, attorneys, accountants, and others in connection with the performance of any duty or trust arising under such agreement; and

(j) To do any and all things which TSM & MJM INVESTMENTS, INC.'s Board of Directors may determine, consistent with the provisions hereof, to be necessary or appropriate to effectuate the purposes of which TSM & MJM INVESTMENTS, INC. is organized as herein set forth, to the extent that the doing of such act or thing is not inconsistent with the provisions of Chapter 607 of Florida Statutes, or any other applicable law or statute of the State of Florida.

### ARTICLE Duration

TSM & MJM INVESTMENTS, INC. shall have perpetual duration.

# ARTICLE IV <u>Shares</u>

TSM & MJM INVESTMENTS, INC. shall be authorized to issue one thousand (1000) shares of capital stock without par value which shall be of one class only, all common with equal rights of vote and upon liquidation.
