**ARTICLES OF INCORPORATION
OF

**ARTICLE I

CAPITAL STOCK

BY-LAWS

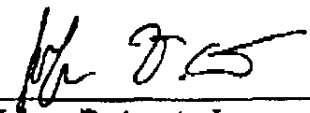

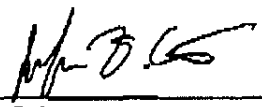

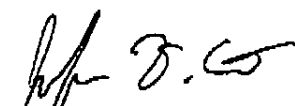
