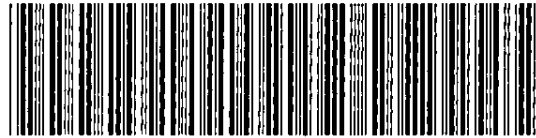

**ARTICLES OF INCORPORATION
OF
EMERALD ENDEAVORS INC.**

ARTICLE I: NAME

The name of the corporation is Emerald Endeavors Inc.

ARTICLE II: PURPOSE


