

**ARTICLES OF INCORPORATION
of
JA LOREN SALON, INC.**

ARTICLE I

Name: The name of this corporation is JA LOREN SALON, INC.

The address of the principal office of this corporation shall be 730 N. Highway 17-92,

ARTICLE II

Duration: This corporation shall have perpetual existence.


