**ARTICLES OF INCORPORATION
OF

The undersigned, being duly licensed to practice law under the laws of the State of Florida, hereby adopts these Articles of Incorporation to form a corporation under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and other laws of the State of Florida.

ARTICLE 1

Corporate Name

The name of this Corporation shall be Joshua Daniel Crapps Law Firm, P.A. (the Corporation). The Corporation shall be a subchapter "S" Corporation pursuant to the Internal Revenue Code.

ARTICLE 2

Mailing Address and Principal Place of Business

The mailing address and the initial principal office of this Corporation is 1018 Thomasville Road, Suite 103, Tallahassee, Florida 32303.

ARTICLE 3

Purposes

This Corporation is formed to engage in every aspect of the practice of law. The professional services involved in this Corporation's practice of law may be rendered only through its officers, agents, and employees who are duly licensed or otherwise legally authorized to practice law in the State of Florida. This Corporation may also invest its funds in real estate,

mortgages, stocks, bonds or any other type of investments, and may own real and personal property necessary for rendering of such professional services.

ARTICLE 4

Corporate Existence

This Corporation shall have perpetual existence, commencing upon filing of the Articles of Incorporation.

ARTICLE 5

Capital Stock

This Corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) per share. None of the authorized shares of this Corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.

ARTICLE 6

Registered Office and Agent

The street address of the initial registered office of this Corporation is 1018 Thomasville Road, Suite 103, Tallahassee, Florida 32303, and the name of the registered agent is Joshua Daniel Crapps.

ARTICLE 7

Initial Board of Directors

This Corporation shall have one (1) director. The number of directors may be increased from time to time by the Bylaws, but shall never be less than one (1). The name and address of the initial director of this Corporation is as follows:

Incorporator


