**To whom it may concern**

- 1. I, Kenna Wright the President of Southern Landscaping & Irrigation Systems, II INC received an emailed notification that a notice of Change or Filing on our Sunbiz with the Florida Department of State, Division of Corporation's records at 12:40 pm on Wednesday August 28<sup>th</sup>, 2024. Immediately I went to Sunbiz to look up the information and it had been changed.**
- 2. We contacted Sunbiz and they told us that we could change it back the next day- which we have done. They also told us to call our local Sheriff's Department and file an Identity Theft report- which we have done. In addition we have contacted our bank and we have also put an alert on our credit. Our Attorney Derek Schroth has also been notified.**
- 3. The name listed for the changes listed on Sunbiz was David Lee Burks Jr, 344 Ruby Lake Loop, Winter Haven FL 33884. We do not have any affiliation with this person nor did we authorize any changes to our information. In fact we are very upset that it was so easy for someone to be able to do this. We gave his information to the deputy. We also looked this person up and they have been in and out of jail for multiple crimes including hotel robberies and bank robberies. The most recent court records show that his charges for a recent crime were dropped a few months ago. The address he listed on Sunbiz is a property that was previously owned by a David Lee Burkes Sr who passed away. The address for David Lee Burks Jr is listed as 5741 Lake Fox Dr E, Winter Haven FL 33884.**
- 4. We understand that this person may have used David Lee Burks Jr's name falsely however based off the persons past presented we cannot confirm this**
- 5. Under Florida Law it states that falsifying information on a document to the Florida Department of State is a third degree felony. Not only do we want to press charges against the responsible party to the fullest extent we are also appalled that it is that easy to change information with out the stet confirming that the information is true.**
- 6. We believe that the State of Florida should be more thorough in vetting changes on business forms. There is a high possibility that this person has attempted to obtain credit cards, bank accounts or loans in our business name in order to defraud us. We request that our account is flagged so that this is not able to happen again. We feel that when we contacted Sunbiz that it should have been able to be changed back immediately.**


