ARTICLE I - NAME

The name of this professional corporation is: EVAN W. TURK P.A.

ARTICLE II - BEGINNING OF CORPORATE EXISTENCE

The existence of this corporation shall commence on the 30th day of
October, 2009.

ARTICLE III - PURPOSE

The nature of the business to be transacted by this professional service corporation is to render professional legal services to the general public and to do all things in connection therewith that are customarily done by attorneys and in accordance with "The Professional Service Corporation Act" of Florida, to invest its funds in real estate, mortgages, stocks, bonds or other types of investments, and it may own real or personal property necessary for the rendering of professional services. 3. No shareholder of the corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

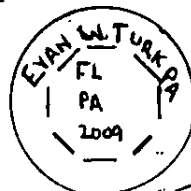
