

ARTICLE I: The name of the Corporation is The Pharmaceutical Applications and Monitoring Corporation

ARTICLE II: The principal place of business and mailing address of the Corporation are:

ARTICLE III: The purposes of the Corporation shall be to provide consulting and advisory services to US and foreign pharmaceutical companies which market or propose to market products for human use whose distribution in the United States is regulated by the United States Food and Drug Administration (FDA). These service shall include:

i. Advising and assisting in the design of preliminary animal based studies and in the design and submission of Investigational New Drug (IND) applications;

ii. Advising and assisting in respect to the selection and contracting of the research institution(s) and principal researcher(s) which shall conduct Phase i, ii and iii studies and monitoring the design and conduct of these studies to assure their compliance with FDA rules and standards;

iii. Advising and assisting in the preparation and submission to FDA of new drug applications (NDA's) and biologics license applications (BLA's);

iv. Assisting product owners by serving as transferee of their BLA or/and or NDA and thereafter exercising the product monitoring, reporting and other responsibilities of FDA product licensees.

ARTICLE IV: The corporation is authorized to issue one hundred (100) no par shares of stock.

ARTICLE V: The corporation is to have perpetual existence.

ARTICLE VI: In furtherance and not in limitation of the powers conferred by statute the Board of Directors is expressly authorized to make, alter or repeal the by laws of the corporation;

ARTICLE VII: Meetings of the Shareholders may be held within or outside the State of Florida as the by-laws may provide;


