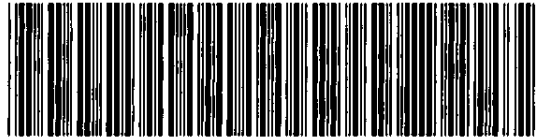

**Name**

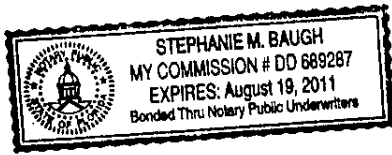


