ARTICLES OF INCORPORATION
OF
CONWAY CANAL COMPANY, INC.

THE UNDERSIGNED, acting as sole incorporator of Conway Canal Company, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be Conway Canal Company, Inc., and the corporate address shall be 5423 Pasadena Dr., Orlando, FL 32809.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

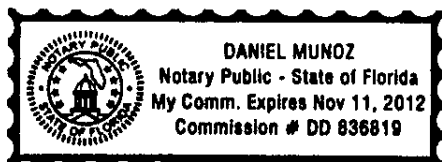

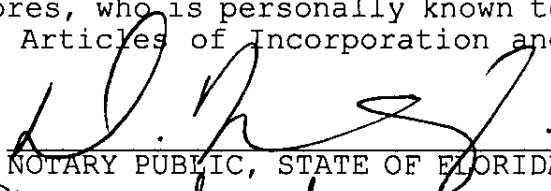

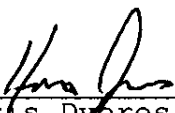
