**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is **BALBINO, INC.**

**ARTICLE II**

The existence of the Corporation shall begin on the date of the filing of these articles of incorporation. This corporation shall engage in any lawful business.

**ARTICLE III**

The street address of the principal office of the Corporation is 5233 SW 24<sup>th</sup> Place, Cape Coral, Florida 33914.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100 par value \$1.00 per share, all of which shall be Common Shares.
