# ARTICLES OF INCORPORATION OF: POOL DOCTORS OF SOUTH FLORIDA INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### ARTICLE I - NAME

The name of this corporation is POOL DOCTORS OF SOUTH FLORIDA INC. (Hereinafter, "Corporation")

# ARTICLE II - DURATION / TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of the filing of theses Articles which the Department of State.

#### ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law.
