ARTICLES OF INCORPORATION

OF

TERI-VI DENTAL, INC.

ARTICLE I - NAME

The name of the corporation is Teri-Vi Dental, Inc., at 60 Sunset Drive, Bay F, West Melbourne, FL 32904 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
