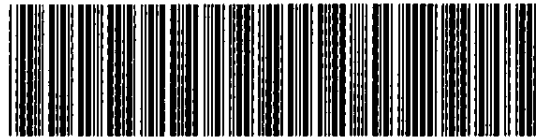



ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is A & S TAX SERVICE, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2010, and shall have perpetual existence.

ARTICLE III. PURPOSE



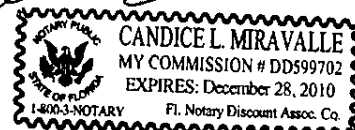
