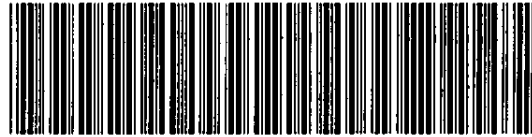

**SECOND:** The principle address of the registered office of the Company in this State is 19928 Casa Verde Way, Fort Myers, Florida 33967.


**THIRD:** The name and address of the resident agent of the Company are Scott Chadwick, 19928 Casa Verde Way, Fort Myers, Florida 33967.
