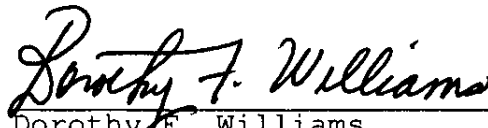
ARTICLE ELEVEN

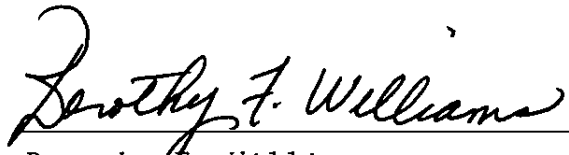
