**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF

(a Florida corporation)

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), Palm Coast 2000, Inc., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:
