#### ARTICLES OF INCORPORATION

The undersigned incorporator, a natural person of legal age for the purpose forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, to who provide services as a real estate broker by persons licensed in the State of Florida as real estate brokers, broker associates or sales associates ("Realtor") in the State of Florida hereby subscribes to, acknowledges and adopts the following Articles of Incorporation.

### ARTICLE I

The name of the proposed corporation shall be DAVID K. MONSOUR, P.A.

### ARTICLE II Duration

This corporation shall commence existence on the date of the execution and acknowledgment of these Articles or on filing of these Articles if that shall occur more than five (5) days thereafter, and shall exist perpetually thereafter, unless sooner dissolved according to law.

### ARTICLE III Nature of Business

- A. This Corporation is formed for the following purposes and shall have the following powers:
- To serve as a real estate broker as a professional corporation and to own, lease
   and/or operate offices for the purpose of providing such services.
- 2. To own real and personal property, to enter into contracts and agreements, and to engage in any lawful business necessary or appropriate in the rendering of such professional services.

- To do everything necessary, proper or convenient for the accomplishment of the purposes set forth herein, and to do every other act incidental thereto which is not forbidden under the laws of the State of Florida or by the provisions of these Articles of Incorporation.
- B. The professional services provided by this corporation shall be carried out only through officers, employees and agents, each of whom is duly licensed or otherwise legally qualified to render professional services in the State of Florida as a duly licensed Realtor.

# ARTICLE IV Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares of ONE AND NO/100 DOLLARS (\$1.00) par value capital stock, which shall be designated as common stock.

All the shares of such common stock shall be paid for in cash or property, real or personal, tangible or intangible, or the lease thereof, or in labor or services in lieu of cash or property, at a just valuation to be fixed by the Board of Directors of the corporation, unless otherwise forbidden by the laws of the State of Florida. The payment thereof does not have to be at the time of issuance, provided such shares are subject to calls thereon by the corporation until such time as the whole consideration therefor shall have been paid. Pursuant to Chapter 621, Florida Statutes, such stock may only be owned by persons duly licensed in Florida as Realtors.

# ARTICLE V Initial Offices and Registered Agent

#### ARTICLE VI Initial Board of Directors

This corporation shall have at least one director. The number of directors may be either increased or diminished from time to time by amendment to the Bylaws adopted by the stockholders.
