## **ARTICLE VI- BOARD OF DIRECTORS**

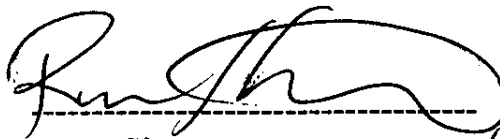

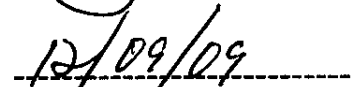
