**ARTICLES OF INCORPORATION**

**FOR**

The undersigned natural person, competent and licensed to practice as a dentist in the State of Florida, acting hereby as incorporator of the purposes of forming a Professional Service Corporation for profit under the provisions of Chapter 607 and 621, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I.  
NAME OF CORPORATION**

The name of the corporation shall be SASHA J. MINOR, D.M.D., P.A.

**ARTICLE II.  
PURPOSES**

The general nature and purposes of business to be transacted, promoted, and carried on by the corporation are:

- a. To engage in every aspect in the field of dentistry, and all its fields of specialization, as are engaged in by dentists.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be dentists in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
- c. To do everything necessary and proper in accomplishing the purposes set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

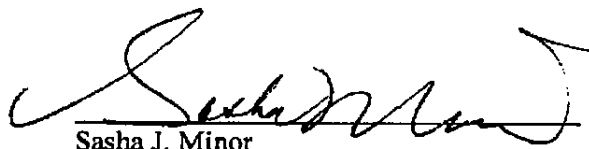
ARTICLE VI
