The undersigned subscriber to these Articles of Incorporation is a natural person a competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

ARTICLE 2 - PURPOSE OF CORPORATION
