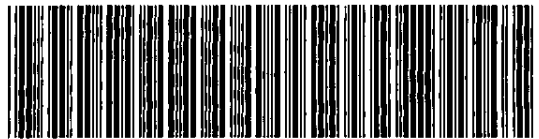

ARTICLE ONE

The name of the corporation is **SRQ FINANCIAL SERVICES, INC.**

The period of its duration is perpetual.
