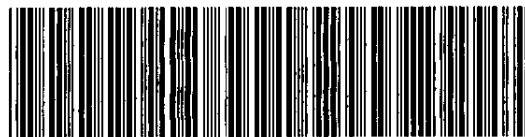

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Bizcasts, Inc. and its principal place of business shall be located at 5301 NW 2nd Avenue #103, Boca Raton, Florida 33487.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
