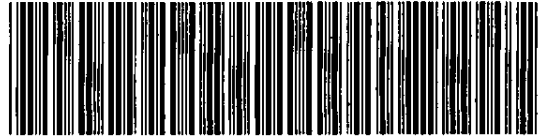


I have decided to just end my corporation in NV and start a brand new one in FL and will call it Patricia J Parks, Inc. I was told I only had to change one part of my name to qualify.
