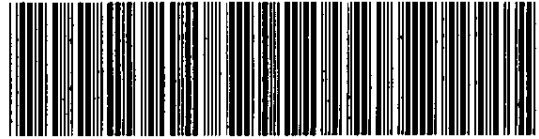

The undersigned, acting as the incorporator of Water Safety Solutions, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

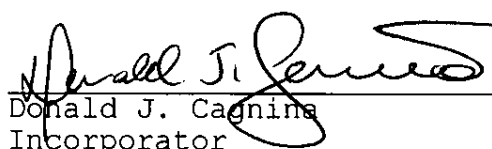
