The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be BASS LAW FIRM, P.A.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The address of the principal office of this corporation shall be 2925 West Cypress Creek Road, Suite 101, Fort Lauderdale, Florida 33309, and the mailing address shall be the same.


