The undersigned subscriber(s) to these Articles of Incorporation, natural persons competent to contract, hereby acting as incorporator(s) for the purpose of forming a Corporation for profit by virtue of the provisions of Chapter 607, Florida Statutes, do hereby adopt the following Articles of Incorporation.

ARTICLE I.

The name of the Corporation shall be: **JNaM, Inc.**

ARTICLE II.

The general nature of the businesses to be transacted by the Corporation shall be of general sales and marketing of mortgage and real estate services.

IN GENERAL, and in connection with the foregoing, the Corporation shall enjoy and may use, exercise and apply all the powers of like corporations conferred by the corporation laws of the State of Florida.

ARTICLE III.

The maximum number of shares of capital stock that the Corporation is authorized to have outstanding at any time shall be fifty thousand (50,000) shares of voting common stock with a par value of One Cent (\$.01) per share. All stock issued shall be paid fully and non-assessable.

ARTICLE IV.

The principal office of this Corporation shall be 10245 Centurion Parkway N., Suite 305, Jacksonville, FL 32256.

ARTICLE V.

The street address of the registered office of this Corporation in Florida shall be Keasler Law Services, LLC d/b/a Keasler Law Group, 12045 Centurion Parkway N., Suite 305, Jacksonville, Florida 32256, and its registered agent at that address shall be **Frank R. Keasler, Jr.** The registered office and registered agent of the Corporation may be changed from time to time upon notification to the proper authorities.

ARTICLE VI.

The name of the subscriber of these Articles of Incorporation is Fred Jay Nauta whose address is 10245 Centurion Parkway N., Suite 305, Jacksonville, FL 32256.

ARTICLE VII.

This Corporation reserves the right to amend, alter, change or repeal any provisions contained herein in the manner now or hereafter prescribed by law, and all rights conferred on shareholders herein are

granted subject to this reservation. The date corporate existence begins shall be December 16, 2009. This election is pursuant to Florida Statute 607.0203(1).

If the ownership of shares of this Corporation shall be in any person, trust, corporation, estate or partnership who is not qualified to own such shares under the provisions of Chapter 621, Florida Statutes, and there is no voluntary transfer of stock contrary to law or these Articles, the Bylaw or a Shareholders' Agreement, then the shareholders may amend these Articles of Incorporation in the manner and method prescribed by law, these Articles and the Bylaws, to effect a change in the nature and purpose of the business authorized by these Articles of Incorporation so this Corporation may conduct any business authorized by Chapter 607, Florida Statutes.

ARTICLE VIII.

Pursuant to §§ 607.0732(1)(a) and 607.0732(2)(a)1, Florida Statutes, this Corporation shall not be controlled by a Board of Directors, but rather it is the agreement of the Shareholders that the Corporation shall be controlled and directed by the majority vote of the shareholders.

IN WITNESS WHEREOF, the undersigned subscribing Incorporator executed these Articles of Incorporation for the purpose of forming this Corporation under the laws of the State of Florida, and does hereby make, subscribe, acknowledge and file in this office of the Secretary of State, State of Florida, these Articles of Incorporation and do certify the facts herein stated are true, all on this 18th day of December, 2009.

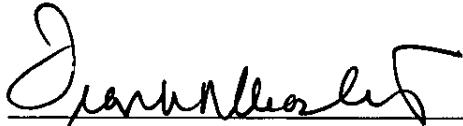
