This corporation is authorized to issue 1000 shares of \$1.00 par value common stock.

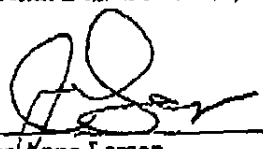
ARTICLE V - MAILING ADDRESS
