**ARTICLES OF INCORPORATION**

The undersigned Incorporator files in the Office of the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

**ARTICLE I. NAME:**

The name of this Corporation shall be:

**ARTICLE II. NATURE OF BUSINESS:**

*The general nature of the business and business to be transacted are as follows:*

- (a) To provide professional services in the practice of real estate sales and to conduct any other lawful business permitted under the applicable laws and regulations of the state of Florida of the United States.
- (b) To acquire, own and sell real and personal property, tangible or intangible, necessary for the purpose of rendering the above services.
