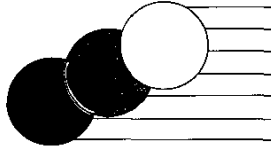

I write with regard to the above-referenced corporation, recently administratively dissolved in the State of Florida due to a declared failure to file its 2000 Corporation Annual Report/Uniform Business Report.

Though previous years' Annual Report Packets were received by this company without incident, it appears for unknown reasons, possibly the name change from Sun Data, Inc. to Solarcom, Inc., the 2000 Annual Report Packet was never received by Solarcom. Nevertheless, on August 24, 2000, Solarcom submitted its 2000 Uniform Business Report, along with a check in the amount of \$150. Unfortunately, I was informed today by a representative of your office that this check was rejected and was ostensibly returned to Solarcom due to a clerical error in its form. As of today's date, I can find no record indicating Solarcom's receipt of this check, nor the notice I am told accompanied it.

In light of such mitigating circumstances, I respectfully request the Florida Department of State to accept the enclosed copy of Solarcom's previously submitted 2000 Uniform Business Report, along with the enclosed \$150.00 filing fee and thereby reverse the administrative dissolution of September 22, 2000. I have also included \$8.75 as payment for a Certificate of Status, to be returned to my attention in the self-addressed, stamped envelope enclosed herewith.
