Though previous years' Annual Report Packets were received by this company without incident, it appears for unknown reasons, possibly the name change from Sun Data, Inc. to Solarcom, Inc., the 2000 Annual Report Packet was never received by Solarcom. Nevertheless, on August 24, 2000, Solarcom submitted its 2000 Uniform Business Report, along with a check in the amount of \$150.
