#### ARTICLES OF INCORPORATION

OF

#### DAVID W. HEYINK, INC.

#### **ARTICLE I - NAME**

The name of the corporation is David W. Heyink, Inc., at 1825 Warton Avenue, Palm Bay, FL 32909 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any of all lawful business.

#### <u>ARTICLE IV - CAPITAL STOCK</u>

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

#### **ARTICLE V - VOTING RIGHTS**

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.
